



Dear Parent/ Guardian(s),

We hope all is well. The ACT Aspire testing period will begin tomorrow, April 19, 2022. During the testing period, SiFA LACS will be running a daily schedule of 8:00am-12:00pm. The ACT Aspire test will be given on campus with assigned testing days. The school is running this modified schedule to ensure smooth proctoring of the test, which is done through an online portal. **Transportation and busing will only be provided in the morning to drop-off students to the SIFA Campus. Students will need to be picked up no later than 1:00pm.**

Each grade level will be assigned testing dates where they may be on campus, while the other grade levels will be having virtual classes from home. Each grade level will have 2 days on campus for the test. Please note that dismissal time for students on campus is 11:30am.
